## *PDP/GMP Scholarships 2018*

### How many scholarships?

3 x 1 PDP (Professional Development Program) course in June/July 2018

(see <https://sha.cornell.edu/admissions-programs/executive-education/classroom-learning/pdp/>)

1 x €5,000 contribution towards GMP (General Managers Program) in June 2018 or January 2019

(see <https://sha.cornell.edu/admissions-programs/executive-education/classroom-learning/gmp/>)

### Who is eligible?

- *hospitality industry professionals living and working in the EMEA Region*
- *interested in becoming actively involved in the Cornell Hotel Society (CHS) or ideally already very active in their respective CHS Chapter*
- *committed to become an Affiliate Member of the CHS (upon completion of six PDP courses or the GMP at the Cornell campus) as soon as possible*

### How to apply?

- *candidates shall be identified and nominated by the Presidents of the eleven CHS Chapters in the EMEA Region; the nominations shall be sent by the respective Chapter Presidents in email format, (1) indicating the desired scholarship (PDP or GMP), (2) including an abstract on the candidate's past commitment to the respective Chapter or future aspirations respectively (recommendation/referral by the Chapter President; in case the Chapter President does not know the candidate personally: recommendation/referral by a CHS Member*

## *PDP/GMP Scholarships 2018*

***AND/OR some hospitality industry top executive who does so), AS WELL AS (3) a motivational letter AND up-to-date CV by the candidate, to the CESC Chairman (christian.walter@pkfhotels.com) by 27 April 2018***

*- upon receipt of the nominations within the deadline, the CESC will evaluate the eligibility of the candidates (residence in the EMEA Region, CHS history/aspirations, recommendation/referral)*

*- the CESC (or an appointed sub-committee) shall evaluate the motivational letters; the candidates shall be informed about the outcome of their applications by 7 May 2018*

*- the PDP scholarship recipients will then be asked to select the course to be financed by the scholarship; the GMP scholarship recipient will be asked to enroll for GMP (the scholarship will be deducted from the regular fee)*

### **How is the scholarship scheme funded?**

*- the scheme has been proposed by the CESC and approved by the membership attending the CHS EMEA Regional Meeting London 2017*

*- the scholarships are financed by the Deiv Salutskij EMEA Scholarship Fund; the Fund receives proceeds from the EMEA Region's scholarship auctions as well as direct gifts from alumni and other supporters*
